<u>Important Notice for Shareholders for updation of PAN, KYC, Nomination, Bank Details etc. and</u> <u>requirements for processing investors' service requests</u>

Dear Shareholders,

This is with reference to the SEBI Circular No. SEBI/HO/MIRSD/MIRSD RTAMB/P/CIR/2021/655 dated November. 2021 and further clarification vide Circular its SEBI/HO/MIRSD/MIRSD RTAMB/P/CIR/2021/687 dated 14th December, 2021, wherein it was directed by SEBI to mandatorily update the PAN, KYC, Nomination details, Bank details, Contact details and Specimen Signature of all the Shareholders holding Shares in physical form and compulsory linking of PAN with AADHAAR on or before April 1, 2023. SEBI has issued another circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 in supersession of above mentioned circular, whereby all shareholders are instructed to complete their KYC. Also the shareholders have to ensure the linking of their PAN with Aadhaar number by June 30, 2023 or any other date as may be specified by the Central Board of Direct Taxes to avoid freezing of your folio.

Keeping in view of the above statutory requirements, shareholders holding shares in physical form are requested to furnish valid PAN, KYC details and Nomination at the earliest to the Company's RTA in the prescribed forms at the earliest but not later than 30th September, 2023 to avoid freezing of their folio on or after 1st October, 2023. Further, no service request received for such frozen folios shall be entertained by the Company/RTA and they will also not be eligible to receive dividend in physical mode.

For this, the shareholder/claimant shall submit duly filled up <u>Form ISR-4</u> (available under download link at company's website) for processing of service requests to Company's RTA.
